**Invitation to Bid for the Purchase of a High-end Multi-Purpose Motor Vehicle**

1. The Philippine Consulate General in Vancouver ("the Consulate"), pursuant to the General Appropriations Act and/or continuing appropriations, intends to apply the sum of Sixty One Thousand Eighty Seven US Dollars and Thirty Five Cents (US\$61,087.35), being the Approved Budget for the Contract (ABC), to payments for the purchase of a high-end multi-purpose motor vehicle. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Consulate now invites bids for the purchase of a Motor Vehicle with the following specifications:

- High-end multipurpose vehicle with engine displacement exceeding 2000 cc, gasoline-fed;
  - Automatic transmission, All Wheel Drive;
  - Flexible space of at least 2,000 liters of cargo;
  - With pre-collision warning and blind spot monitoring systems;
  - Intelligence Drive convenience systems
  - Heated leather seats and steering wheel;
  - Roller blinds for rear side windows; and
  - Integrated GPS and audio system with blue tooth/wifi connectivity;
2. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."


Bidding is open to all interested bidders, subject to the conditions of eligibility provided under the IRR of RA9184.

4. Interested bidders may obtain additional information from the Consulate's Bids and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at 999 Canada Place, Suite 660, Vancouver, BC, Canada, from Monday to Friday, 9:00 am-5:00 pm.
5. Bids must be submitted, on or before **12:00 noon of 22 September 2017**, to the BAC Secretariat of the Consulate at the abovementioned address. Late bids shall not be accepted.

Opening of Bids shall be held on **22 September 2017 at 3:00 p.m.** at the Consulate's Conference Room.

6. The Consulate reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
