BAC Resolution No. 005 - 2023

Resolution Recommending Procurement of Services of a Professional Photographer for *Proudly Philippines* Food and Travel Fair event to be organized by the Philippine Consulate General in Vancouver on 03 June 2023, and the Awarding of the Contract to Ms. Marzia Sager with the total amount of Two Hundred Canadian Dollars (CAD\$ 200.00)

WHEREAS, the DFA's Strategic Plan and its Economic Security Strategic Goals mandate the Foreign Service Posts to intensify economic promotion activities for trade, investment, tourism and services, identify or develop business opportunities for Philippine Micro, Small & Medium Enterprises (MSMEs) through promotional activities and harnessing the presence of overseas Filipinos;

WHEREAS, the Philippine Consulate General in Vancouver (Consulate) started organizing an annual food and travel Fair in 2019, dubbed as *Proudly Philippines*;

WHEREAS, the *Proudly Philippines* will highlight Filipino food and businesses, novelty items and tourist destinations through local vendor participants and presentation of cultural performances (songs and Philippine dances) from various Filipino performers and cultural groups;

WHEREAS, Republic Act 9184 and its Implementing Rules and Regulations (IRR), and the Government Procurement Policy Board (GPPB) Resolution No. 28-2017 dated 31 July 2017, prescribe the rules and procedures to be followed by government entities in the procurement of goods and services, infrastructure projects, and consulting services to be procured and performed overseas;

WHEREAS, in accordance with Section 7.2 of the 2016 Revised IRR, and Annex A(3)(a) of GPPB Resolution 28-2017, the said event is included in the Consulate's Annual Procurement Plan for the Fiscal Year 2023;

WHEREAS, the Consulate intends to hire and engage the services of a professional photographer based in Vancouver, British Columbia, for *Proudly Philippines Food and Travel Fair* on 03 June 2023;

WHEREAS, pursuant to Item 3(b) of Resolution No. 28-2017, the Bids and Awards Committee (BAC) caused the posting on its website and in a conspicuous place in the Consulate, of the Request for Quotations from professional photographers who can meet the following considerations: 1) expertise in photography catering to large crowd events, 2) provision and set up of a photo booth for *Proudly Philippines* event from 9:00 a.m. to 4:00 p.m., and 3) provision of a digital link for the photos to be downloaded by guests after the event;

WHEREAS, in response to the Request for Quotations, the following three (3) reputable companies provided quotations:

WHEREAS, upon evaluation of the BAC, Ms. Marzia Sager of EM Sager Photography submitted the lowest quotation in the amount of Two Hundred Canadian Dollars (CAD\$ 200.00) exclusive of taxes, is technically and financially capable to meet the requirements of the Consulate, and the reasonable cost is most advantageous to the Philippine Government;

NOW THEREFORE, this Committee unanimously resolves to recommend to the Head of the Procuring Entity (HOPE) of the Consulate General of the Philippines in Vancouver, the procurement of professional photography services with provision for a photo booth dedicated to *Proudly Philippines* on 03 June 2023, and the Awarding of the Contract to Ms. Marzia Sager of EM Sager Photography, with the amount of Two Hundred Canadian Dollars (CAD\$ 200.00), subject to the signing of the contract.
