BAC Resolution No. 007 – 2023

RESOLUTION RECOMMENDING LEASE OF VENUE FOR THE PHILIPPINE CONSULATE GENERAL FAMILY PICNIC ON 15 JULY 2023 IN BRITISH COLUMBIA, AND THE AWARDING OF THE CONTRACT TO CULTUS LAKE PARK BOARD WITH THE TOTAL BID AMOUNT OF TWO HUNDRED EIGHTY-EIGHT CANADIAN DOLLARS (CAD\$ 288.00)

WHEREAS, the Consulate General of the Philippines in Vancouver ("the Consulate") has decided to hold its family picnic activity in British Columbia on 15 July 2023;

WHEREAS, the one-day family picnic activity aims to foster camaraderie, trust, friendship, strengthen bonds between personnel, boost employee's morale, rejuvenate employee's spirit, and encourage integration among consulate personnel and their families;

WHEREAS, to provide a conducive environment for the conduct of the Consulate's Family Picnic, the Consulate intends to lease an appropriate outdoor venue with parks, trails and ample space for family-fun activities for participating personnel and their families;

WHEREAS, Republic Act 9184 and its Implementing Rules and Regulations (IRR), as well as the Government Procurement Policy Board (GPPB) Resolution No. 28-2017 dated 31 July 2017, prescribe the rules and procedures to be followed by agencies for goods and services to be procured and performed abroad;

WHEREAS, in accordance with Section 7.2 of the IRR and Annex A(3)(a) of GPPB Resolution No. 28-2017, the Consulate's Family Picnic is included in the Consulate's approved Annual Procurement Plan for the Fiscal Year 2023;

WHEREAS, pursuant to Item 3(b) of Resolution No. 28-2017, the Bids and Awards Committee (BAC) caused the posting on its website, and a conspicuous place in the Consulate, of the Request for Quotations from service providers in British Columbia that can meet the following criteria: 1) venue that can accommodate 50 persons at a given time, 2) near a public parking and with clean restrooms, 3) setting up of tent/s is allowed, 4) accessibility to the public;

WHEREAS, Cultus Lake Park Board, the only quotation received by this Committee, has been found to be responsive to the bidding requirements and is technically, legally and financially capable to meet the requirements of the Consulate in terms of the specifications of the venue for the Consulate's Family Picnic;

NOW THEREFORE, this Committee unanimously resolves, as it is hereby resolved, to recommend to the Head of the Procuring Entity (HOPE) of the Consulate General of the Philippines in Vancouver, the lease of venue for the conduct of the Consulate's Family Picnic in British Columbia on 15 July 2023, and the awarding of the Contract, to **Cultus Lake Park Board**, in Cultus Lake, British Columbia, in the amount of **Two Hundred Eighty-Eight Canadian Dollars (CAD\$ 288.00)**, inclusive of all taxes, subject to the above requirements and compliance by the end-user of the existing auditing rules and regulations.
